SUB: ADHERENCE OF PROVISION OF THE AFFILIATION BYE-LAWS OF CBSE – Reg

Adherence to various provisions of Affiliation Bye-Laws is the prime responsibility of every affiliated school of CBSE. Therefore, the attention of all the Heads of the Institutions affiliated to the Board is once again, drawn to Rule No 2.4.7(b) of revamped Affiliation Bye-Laws, 2018 in the light of recent observations and reports that a large number of CBSE schools are not following the said provision laid down in the Affiliation Bye-laws of the Board which is mandatory in nature.

2. Rule 2.4.7(b) of CBSE Affiliation Bye-Laws mandates that the School shall put a list of prescribed books on its website with the written declaration duly signed by the Manager and the Principal to the effect that they have gone through the contents of the books prescribed by the school and own the responsibility. If a school is found prescribing a book having any objectionable content, the responsibility for such content shall lie with the school and action will be initiated against the School by the Board.

3. Therefore, all the schools affiliated to CBSE are once again directed to follow the relevant provision mentioned in Affiliation Bye-Laws, 2018 & subsequent guidelines issued from time to time and ensure compliance of the same without fail.

4. In case of any report of violation, the Board will not consider the case of school for Extension/Upgradation of Affiliation and this may also lead to action against the schools as per laid down provisions of Affiliation Bye-Laws, 2018.
